




Since 2010, we have brought significant improvements to almost every aspect of Bloedel Reserve.

In 2010, we eliminated our reservation system and began actively welcoming the public to the Reserve.



HORTICULTURE & DESIGN

Buxton Bird Marsh & Meadow



At the heart of Bloedel Reserve is the landscape itself—the forests and meadows, the cultivated gardens, ponds and wildlife habitats. The expansion and renovation of the Buxton Bird Marsh & Meadow is a premiere example of how we strive to create an immersive experience for guests while enriching and protecting the natural landscape and wildlife.

Doubling its size from 5 to 10 acres, the landscape redesign includes a new boardwalk to protect the pond at the center of the marsh, as well as rerouted trails, new viewpoints, and 50,000 bulbs planted in the meadow adjacent to the marsh. The Environmental Horticulture Center






Bloedel Reserve is renowned for sustainable and green horticultural practices. The Environmental Horticulture Center (EHC) is a planned, multiphase project that will provide much needed modernization of the "back of house" buildings and systems that serve all aspects of our commitment to conservation and sustainability.

The EHC will also be a valuable learning lab for horticultural education and research. In 2020, we will break ground for the first stage of the project a substantially improved composting facility.



Strolls for Well-Being/Virginia Mason Pilot Program

The positive connection between time spent in nature and wellness is a concept that spans millennia. It is a truth that was championed by Prentice Bloedel in his originating design and core purpose of the Reserve. The Strolls for Well-Being program, initiated in 2014, gives participants the opportunity to immerse themselves in nature through a series of free-of-charge structured walks and educational sessions that are designed to be both meditative and healing.

Physicians at Virginia Mason are partnering with Bloedel Reserve to explore and quantify through biometrics the positive benefits of immersion in nature. What we learn together could have a profound impact on health and wellness in the future.
