

# HORTICULTURE & DESIGN



## WHAT WE LEARNED

Nature doesn't stop, even when humans have to.

What began as a normal year was suddenly turned upside down by COVID-19. Washington State was one of the first states hardest hit by the virus and in March of 2020 we were forced to close the Reserve for almost three months.

Shutting down wasn't as simple as closing our offices. While our administrative staff could, by and large, work remotely, our intrepid grounds and facilities teams had to figure out how to care for a 150-acre facility with a socially distanced and masked skeleton crew. Remarkably, the grounds were ready for visitors when we opened again in early June. When guests arrived, the Buxton Bird Marsh & Meadow was in spectacular full bloom...but to the trained eye, full of weeds that had taken hold during the months of closure.





## WHERE WE'RE GOING

Stepping back lets you step forward with fresh eyes.

Major garden and landscaping projects were put on hold for much of 2020 due to the pandemic. But with a larger crew back, we have stepped up our work on the grounds, including removing those invasive weeds.

In 2021, thanks to a grant from the Pendleton and Elisabeth Miller Charitable Foundation, we will begin work on a new Arrival Garden. The landscaped areas comprising the entrance to the Reserve were designed at different times, and until now there has not been an effort to consider them holistically. The new design will create a fitting first impression of the Reserve by addressing specimen tree loss, improving views, and connecting adjacent landscapes.

# CONSERVATION & STEWARDSHIP



Appreciate what you have and celebrate what makes you unique.

It is easy to take for granted that which is familiar, until it's gone... even temporarily. We were reminded that what we do as custodians of this quintessential piece of the Pacific Northwest profoundly matters to our community. And we were reminded that sharing this place is an essential part of our conservation mission.

The importance of the Reserve became ever more apparent when guests were able to return to the grounds. The outpouring of delight, love, and gratitude was nothing short of astonishing.





## WHERE WE'RE GOING

Knowledge is great. It's even greater when it is shared for the common good.

Using our Heritage Landscape Report and other resources, we will be sharing more information about the Reserve's history and evolution, as well as our plans for its future, including our continuing commitment to green horticultural practices.

Composting is a vital part of how we put that commitment into action. Near the end of 2020, thanks to pre-pandemic gifts from several generous donors, we began construction of a new composting facility. The first phase of our Environmental Horticulture Center, this facility will significantly improve our composting capacities. At this writing, construction is moving quickly toward completion this spring.

## CREATIVITY & INSPIRATION



## WHAT WE LEARNED

*Creativity will find a way to express itself, in spite of the obstacles.* 

Like the grounds themselves, our signature Creative Residency program had to come to a halt when the facilities closed beginning in March.

Our new program manager (who was hired just days before the closure) rose to the challenge by rescheduling those 2020 Residents whose stays were cut short, not only by COVID but also by summer wildfires, so they could safely return when conditions and their schedules allowed. In the interim, she found ways to expand virtual access to their work with stories, photos, and videos posted to our website.





## WHERE WE'RE GOING

*Imagination thrives on the new, the unforeseen, and the unexpected.* 

The values inherent in our IDEA initiatives—inclusion, diversity, equity and accessibility—play an especially important part of the Creative Residency program. The Program's new juried application process, introduced at the end of 2020, will bring our most diverse group of Residents yet to the grounds in 2021. We are excited to see what their time at Bloedel inspires and what they will share with their colleagues, friends, and fans wherever they call home.

Also, we will continue to introduce Residents to our local community through partnerships with arts and culture organizations like BIMA (Bainbridge Island Museum of Art) and BARN (Bainbridge Artisan Resource Network).






Nature heals.

Our Strolls for Well-Being program has from the very beginning been built on the concept that immersion in nature is good for the body, mind, and soul. When the Reserve had to shut down that also shut down our onsite Strolls orientations and adjunct workshops. And the Virginia Mason team that had been working with us to measure the impact of the program on participant health had to turn its attention to the COVID crisis.

So we adapted the original onsite Strolls program into Strolls at Home. The prompts for 12 self-guided walks are downloadable 24/7 from our website, allowing participants to embrace the benefits of being in nature no matter where they are.





## WHERE WE'RE GOING

*Given the opportunity, we all benefit from time spent in nature.* 

We have reintroduced our free Strolls for Well-Being program in a virtual/actual hybrid format. Group meetings are held on Zoom, and participants can once again take their solo themed walks onsite. Our Grief Group partnership with Island Volunteer Caregivers has also restarted.

But downturn in revenue and budget cuts have delayed the hiring of a program manager for Nature & Well-Being initiatives. We hope to grow this part of our programming when resources become available. And we hope to share our Strolls programs with other public gardens, parks, and outdoor spaces whose guests could benefit from our findings about the healing properties of immersion in nature.

# SERVING THE COMMUNITY



#### FLEXIBILITY, RESILIENCE & TEAMWORK

#### STAYING CONNECTED VIA VIRTUAL VISITS AND WEEKLY NEWS

More than 15,000 friends and fans have embraced our weekly E-Newsletter, which keeps members, donors, and guests up to date with our latest news.

And our new website "digest"— From Our Backyard to Yours provides behind-the-scenes photos, videos, and articles so visitors can experience a bit of Bloedel no matter where they are.

#### CREATING A SAFE EXPERIENCE ON-SITE

Strict health and safety measures allowed us to get permission from the Governor's Office to reopen the Reserve earlier than we had anticipated. In fact, we were the first public garden in Washington State to reopen. We instituted a Timed Ticketing system to capture an accurate headcount of who is on the grounds. We converted our trail system to a one-way route and began requiring that guests and staff wear masks and observe social distancing.

## WELCOMING BACK THE COMMUNITY FOR FREE

When we reopened the Reserve in early June, we offered free admission for more than 3,500 people over two full weeks. Guests were able to try the new Timed Ticketing system, the new one-way trail route, and the social distancing protocols.

The feedback was immediate and overwhelmingly positive. As one guest put it, "So wonderful to enjoy nature during this time and so grateful to have Bloedel so close by." In October, we did it again, expanding what was to be a single day into Gratitude Weekend in order to thank our community with more free access to the Reserve.

#### FINDING NEW SOURCES OF REVENUE

The impact of COVID-19 and the subsequent closure of the Reserve cannot be overstated. The decline in revenue was swift and immediate. Our onsite summer Garden Party, which traditionally raises half of our annual mission support, became a major casualty.

Unable to host gatherings on the grounds, we went virtual, with an online fundraising campaign that was wildly successful, thanks to the community's above-and-beyond generosity. And friends and fans enthusiastically embraced the new Online Shop for their holiday shopping.



Speaking of the holidays, in 2019 we retired our Holiday Village display and began planning something new. Our plans had to change when COVID hit. "Winter in the Woods" became our answer—an entirely outdoor experience with festively decorated trails, a food drive in partnership with Kitsap YWCA for families in need, and a Wishing Tree to capture hopes for the new year. The result? More than 5,000 guests booked tickets in December, we collected more than 700 food items for the Y, and nearly 2,000 wishes were hung on the Wishing Tree. A whole new tradition has begun.
